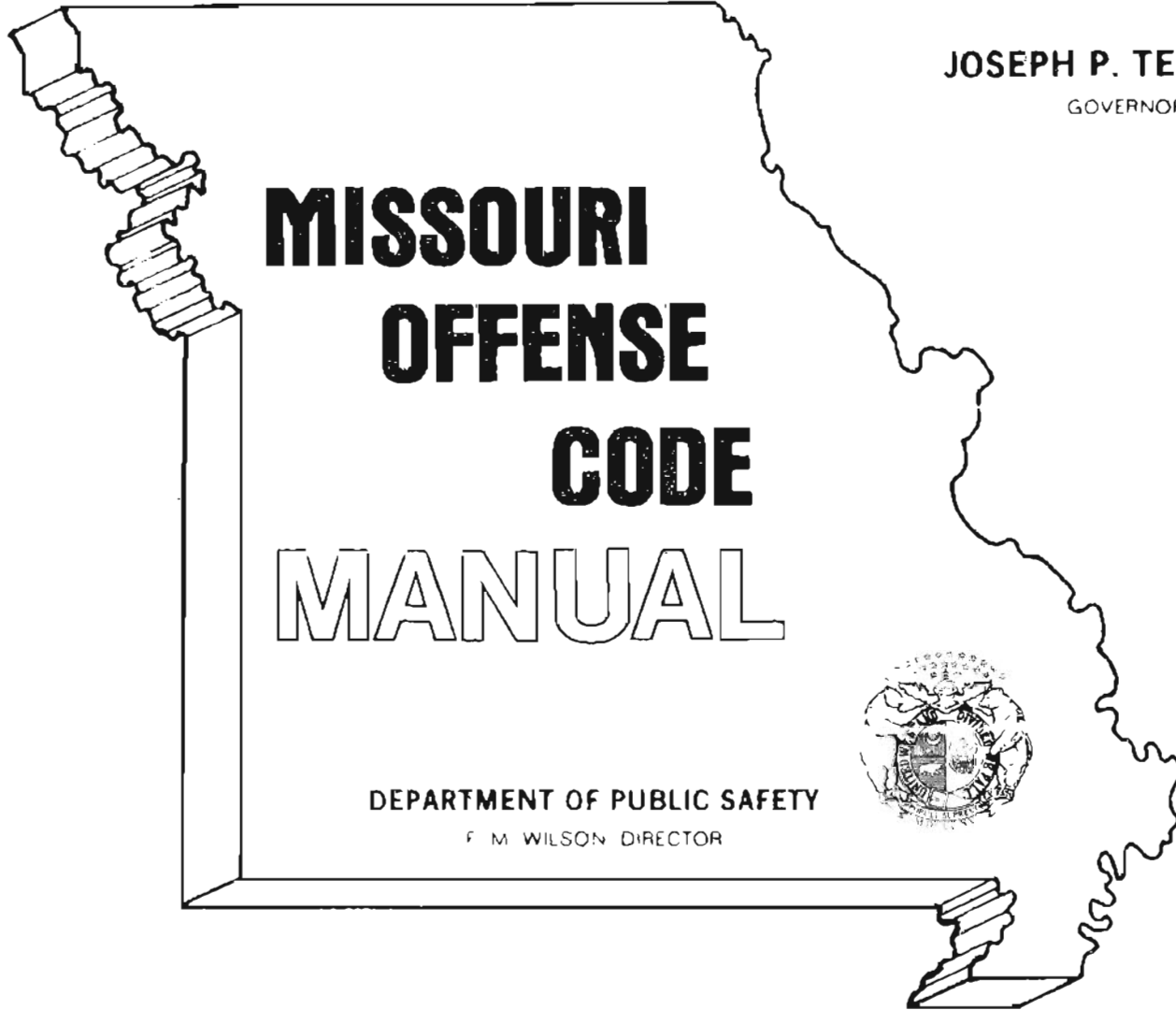

PREFACE

With the development of computer systems that link the various criminal justice agencies together within the state, a common system of coding charges is needed to minimize communications problems. The Comprehensive Data Systems (CDS) Policy Advisory Board authorized the formation of a special Task Force to develop such a code to be implemented coincidental with the effective date of the Missouri Revised Criminal Code.

The following agencies participated in this effort: Regional Justice Information Service (REJIS); St. Louis Metropolitan Police Department; Kansas City Police Department (ALERT); Missouri State Highway Patrol; Missouri State Supreme Court (SWJIS); Department of Public Safety; Division of Corrections; Division of Probation and Parole, and the Missouri Department of Revenue.

I. INTRODUCTION

WHAT IS A CHARGE CODE?

A charge code is a combination of characters, in this case all numeric, that when read and interpreted identify a law violation. In this particular code, additional descriptive information is also a part of the code.

WHAT IS THE PURPOSE OF A CODE?

The purpose of a code is to 1) standardize the terminology used in situations where charges must be identified, 2) reduce the effort needed to key a charge into a computer file, 3) facilitate the exchange of charge information between segments of the criminal justice system and their supporting computer operations, and 4) support statistical and analytical needs of state and local agencies.

WHAT WILL THIS CHARGE CODE DO?

1. Identify a specific offense and statute citation.
2. Correlate violations of state and local laws with offense descriptions used by NCIC.
3. Correlate violations of state and local laws with offense descriptions used by the Uniform Crime Reporting system.
4. Provides a structure to be followed in coding local or county ordinance violations.
5. Provides a structure for the coding of civil matters.
6. Provide identifiers for various categories of offenses to enable statistical or analytical research projects to be carried out.

WHEN IS THE CODE USED?

All charges identified in statewide computer systems (i.e. MULES, wanted records, Computerized Criminal History Records and SWJIS judicial records) will eventually require use of the codes. The regional computer systems may also establish a requirement that charges being input into these systems must be in this standard format.

Outside of these system requirements, the use of the State Wide Charge Code is voluntary. Agencies may, however, elect to use the English (text) description of the codes as part of their manual records, such as booking sheets, reports, etc. This will insure standard wording of charges on these manual forms and provides a ready reference to the appropriate statute authority.

WHAT IS THE SCOPE OF THE CODING?

The charge code developed by the Task Force does not contain every possible charge that exists in the Missouri statutes. It does contain all possible charges under the Revised Criminal Code, it also contains the more popular or frequently used charges. As new statutes are enacted, statutes repealed, or a need is demonstrated for existing statutes to be coded, the charge code will be updated.

WHO IS RESPONSIBLE FOR MAINTAINING THE CODE?

The Missouri Department of Public Safety has responsibility for maintaining the State Criminal Codes, Civil Action Codes, Federal Codes, and Miscellaneous Codes. Local agencies are responsible for local ordinance codes. (See Section IV, Code Maintenance, for further details.)

QUESTIONS ABOUT THE CODE.

All questions concerning the Charge Code, its use, etc., should be directed to the agency that provides computer support for your operation. If your agency is not participating in computer operations, questions may be directed to the Department of Public Safety in Jefferson City. Personnel there will either answer the questions or refer them to one of the computer centers for an answer.

II. CODE DESCRIPTION

The code is composed of four segments.

The first five characters (segments 1 and 2) are always required. Segments 3 and 4 are optional, but under some circumstances both must be used. Therefore, either a minimum of 5 or a maximum of 8 keystrokes will be needed to describe any charge found in the Charge Code.

State
MAJOR CATEGORY IDENTIFIER

The first two (2) characters of the code have been used to identify the major grouping or category of charges. For criminal violations at the state level, the NCIC breakdown is used, i.e., Homicide, Sexual Assault, etc. For non-state level codes the characters have been used to identify Federal, Civil Actions, Local Ordinances, and Miscellaneous codes.

The major category codes are as follows:

Local/County Ordinance charges have a range of values to be used as Major Category Codes. This range of values can be divided similar to state statute codes or in any other manner that suits the needs of the particular agency. For example, one agency can use Code 75 for local sanitation ordinance violation, while another may use 75 for ordinances relating to liquor violations. For additional information see Section IV. CODE MAINTENANCE.

STATUTE REFERENCE

The next three (3) characters of the code are used to identify a specific statute or ordinance, the violation of which constitutes a charge. For each major category identified there are 998 possible individual specific charges. In the event that someone is being charged with an offense which is not already coded, the user would enter three nines (999) in this field. This will then permit the entry of "free text" or the charge wording selected by that user.

OFFENSE DESCRIPTOR

The next two (2) characters of the code are used to give additional information about the offense that is useful in conducting statistical analysis. This description is not directly related to the statute involved but does give information about the event. The last two characters of the NCIC Offense coding scheme are used for these positions. Edits have been established which prevent the use of an invalid code. Part 3, Offense Descriptors, lists the valid Offense Descriptors used in the State Wide Charge Code.

An example of this code is: 05 Willful kill-public officer-gun. The use of this code section is optional but is required under some circumstances, depending upon the computer system supporting your agency. Zeroes (00) indicate not applicable.

OFFENSE MODIFIER

The next character of the code is used to modify the basic charge to one of three alternate states: attempt, accessory after the fact, or conspiracy. The use of the Offense Modifier is optional unless the charge requires its use. A zero 0 indicates not applicable or the offense charged is the basic charge identified by the code.

SAMPLE CODE FOR HOMICIDE

The following is an example of how the four segments of the code would look for all possible options for homicide.

Only the first five (5) characters are required — thus a charge of capital murder would be coded 10010. If the option to use the Offense Descriptor field was selected, this might then be coded 10010030 indicating capital murder, willful killing of a non-family member using a gun and the Offense Modifier was not applicable. A conspiracy to commit the same offense would be coded 1001003.

III. RECORD DESCRIPTION

The code (the 5 or 8 characters that are entered by the operator in the computer) has been discussed in detail, but the charge code record supported by this code is most important. Each code (except the free text designation of 999) must be established beforehand and entered into a charge code table which is stored in the computer. These codes are then known as charge code records. Each record must contain certain information that will enable later output to meet the needs of those using the code and to permit checks to be made that will help minimize the possibility of a code being entered incorrectly.

The following information is used to make up the charge code record.

1. The five (5) character charge code.

2. A twenty-four (24) character abbreviated English description of the charge.
3. An eighty (80) character English description of the charge.
4. The statute being referenced by
 - a. Chapter number
 - b. Section number, and when applicable
 - c. Paragraph number, and
 - d. Two (2) sub-paragraph numbers.
5. The offense type. (Felony, Misdemeanor/Class A, B, etc.)
6. The Uniform Crime Reports (UCR) Classification (2 characters).
7. The NCIC Offense Code
 - a. Major classification
 - b. The range (low and high values) of charge descriptors).
8. The effective date of the statute.
9. The date the statute was repealed.
10. Valid offense modifiers
 - a. Attempt
 - b. Accessory after the Fact
 - c. Conspiracy
11. DOR Traffic Information consisting of offense, abbreviation, violation code and point value.

NOTE: In the initial charge code load only those charges that have effective dates of 1/1/79 will have that date completed. Also, no repealed statutes are being loaded, so that field will be blank on all records.

IV. CODE MAINTENANCE

There are several levels of responsibility in maintaining the code. The basic or central responsibility for coordination and maintaining the code for State felonies and Misdemeanors, Federal charges, Civil Action Codes, and Miscellaneous Codes will be with the Department of Public Safety in Jefferson City. Once the initial code is developed and put into operation, the Department of Public Safety will be responsible for:

- a. Adding new charges based on new legislation.
- b. Deleting charges based on repealing legislation, or the finding of the court.
- c. Adding charges based on existing legislation when the need for the additional charge is demonstrated.
- d. Advising all code users of the changes.

All computer centers which support optional City/County Ordinance codes have a dual responsibility. First, they shall insure that their systems support and are synchronized with the statewide system. Second, they have complete responsibility for the maintenance of the City/County Ordinance codes. Code users can request that the charge code be updated. The request should be in writing by the agency head, giving full particulars supporting the request. An example of when this would be necessary is when an agency has on several occasions had to use the free text code for the major category to initiate the appropriate record keeping process. A request to have that particular charge included in the code would be submitted to the agency supporting that section of the system. After appropriate research to verify the wording and statute reference the charge would be added to the code list. For State misdemeanors and felonies, the Civil Action, Federal Charges, and Miscellaneous codes, the request would be submitted to the Department of Public Safety. For local ordinance charges the request would have to be submitted to the appropriate agency responsible for maintaining local ordinances.

The code user is responsible for maintaining the code manual and promptly updating it when notice is received to make changes.

V. USING THE CHARGE CODE

Initially all code users will be provided with a complete copy of the Statewide Charge Code Manual which will contain all felony and misdemeanor offenses, Civil Actions, Federal Charges, and Miscellaneous codes that have been coded. Thereafter, periodic announcements will be made concerning updates that have been made. Individual code users will be responsible for updating their copies of the code manual. Periodically, all updates will be included in a revised manual which will be distributed.

Publication of local option codes, revisions and distribution is the sole responsibility of the agency supporting that code usage.

The Statewide Manual, in addition to the code number, will contain the 24 and 80 character English descriptions of the charges, the statute reference, offense type and classification, UCR classification, NCIC Offense Code, Effective and Repeal dates, the valid offense descriptors, and the valid offense modifiers. NOTE: See Record Description for more information.

The format used to publish local option codes is left to the discretion of the computer centers supporting those code structures. However, they are encouraged to use the same format as the Statewide Manual.

VI. CONVERSION

The revised criminal code requires that offenses committed prior to the effective date of the revision be processed in accordance with standards in effect at the time of offense. Therefore, until the statute of limitations precludes prosecution, the coding of an offense committed prior to January 1, 1979, will utilize the free text code. The operator must select the major category, enter that number plus 999 and then type in the proper wording of the charge.

For all other charges the conversion will be immediate and the new codes will be used right away.

VII. BENEFITS

There are many benefits to having a statewide charge coding system and in particular the scheme that has been developed in this project.

On a statewide basis communication is much easier. The creation of wanted records can be handled in regional systems and MULES without translation. The development of a criminal history file and reading the output is made easier. Exchange of information between criminal justice segments (police, prosecutors, court, corrections, etc.) is standardized which is important to computerization of these functions.

By adding certain identifiers (NCIC and UCR) and indicators in the code, those interested in doing statistical or analytical work along these lines have an easier job. The code establishes the relationship between state law and the definitions that NCIC and UCR uses. Also, charges that are not a part of the code can be added on a miscellaneous basis to the major category classification of the offense. This prevents that charge from being "lost" in later analysis of that major category.
